## IMPORTANT INFORMATION FOR STUDENTS APPLYING FOR THE CERTIFICATE PROGRAMS

**Eligibility:** Application to most UCSC Extension certificate programs is open to international students who have the following minimum qualifications:

1. Bachelor's Degree or College Diploma
2. English Proficiency score: iBT TOEFL 70, IELTS 6.0, or equivalent and accepted qualifications.  
\*English Waiver may also apply if you have at least 2 years of recent study or completed a degree at university or college from an English speaking country.

Successful applicants are issued a letter of admission to UCSC Extension along with a signed I-20 (Certificate of Eligibility) to support an application for a student visa at U.S. Embassies or Consulates or a change of status in the U.S.

**Academic Requirements:** International students must enroll in a minimum 12 units of classes every quarter with passing grades in these classes. Only 3 units of online classes may be taken each quarter. The minimum 12 unit requirement does not apply in the final quarter of the certificate program.

**Optional Practical Training (OPT):** OPT is available to F-1 students who have been lawfully enrolled on a full-time basis in an approved college, university, conservatory or seminary for at least nine consecutive months and who have completed their program. One year of OPT is allowed after each level of education (for example, a degree or certificate program).

**A \$100 OPT Advising Fee will apply. Programs shorter than nine months do not qualify for practical training.**
